

# CHANGE OF OWNERSHIP FORM



## WARRANTY TRANSFER PROCEDURE AND INFORMATION

To qualify for a limited warranty transfer an original warranty registration and yearly water samples must be on file with Greentech Manufacturing, Inc.

Greentech Manufacturing, Inc. requires all stoves go through a dealer stove check to transfer an existing warranty. This Stove Check consists of a physical Dealer inspection, including pictures and a written recommendation and a change of ownership form submitted to Greentech Manufacturing, Inc.

Pictures must be taken of the back of the stove with the door open, front of the stove, firebox, all heat exchanger doors, and plumbing.

**It is the responsibility of the customer to pay for all fees associated with the stove check. There is a fee collected from the local dealer for completing the on-site dealer stove check. Dealer collects fee from**

**customer. Fees average \$200 but could be more or less depending on customer's location from dealership. A dealer stove check must be completed by the local dealer or we cannot transfer a warranty.**

Once a completed Change of Ownership form has been submitted Greentech Manufacturing, Inc. will approve or deny the request and email a copy back to the local dealer as notification of the decision. If the warranty transfer is approved, a warranty registration must be completed and submitted within thirty (30) days to complete the transfer process.

A transferred warranty begins where the original warranty is at in its current 20-year term. (Example: If the Crown Royal Stove is 5 years old the warranty to be transferred is the remaining 15 years of the limited warranty.)
